SUPPLEMENTAL DATA BOOK REPORTS

Overview

AHCCCS is providing additional data/reports to supplement the Data Book Files, and to assist Offerors in preparing bids and/or reviewing AHCCCS' rates/ranges. Acute Care Bid Excluded Data Summary Tables/Reports

Effective 10/01/13 the Acute Care Contractor will no longer be responsible for covering certain members thus the data related to those members have been excluded from the Acute Care and Delivery Supplement Data Book Files. In addition the Data Book Files exclude those risk groups that have been eliminated (i.e. HIFA and MED). The descriptions and/or data below represent the data that have been excluded.

Seriously Mentally III (SMI) Acute Care Data

This data represents those members whose acute care expenditures will be integrated into the Maricopa RBHA effective 10/01/13 (i.e. SMI members in Maricopa County). This data was released as part of the current Maricopa RBHA RFP and excludes those members in the HIFA or MED risk groups. This data only includes CYE 09, CYE 10 and CYE11. CRS Program Acute Care and Specialty Care Services –Inpatient Hospital Statistics

This report utilizes data for CRS acute care and specialty care services. The data does not include any completion factors or other adjustments.

The member months data used to calculate the Annualized Admits per 1,000 includes all CRS coverage types, not just those who will be enrolled in the CRS program (i.e. CRS Fully Integrated and CRS Partially-Integrated – Acute coverage types). These member months are the same member months posted in the Bidders' Library, Data Supplement, Section C – Data Book Information, Data Book Layout/File Description, Table I.
