At that meeting there will be a discussion about DDD membership on the Council.

V. State Agency Updates Medicaid/BH RSA/VR Housing	 Medicaid/BH Dana Hearn, AHCCCS/Division of Community Advocacy and Intergovernmental Relations (DCAIR) gave updates on the Following priorities: AZ Provide Enrollment Portal which will go live on 8/31/20, Electronic Visit Verification go live date is now 1/1/21, 1115 Waiver Renewal App., CMDP Integrated Care Transition go live date for this is 4/1/21, Enhanced School Based Claiming Prog., RBHA Competitive Contract Expansion with a go live date of 10/1/22. Dana also highlighted information on the Public Health Emergency (PHE) Extension, HHS Provider Relief Funding Announcement and application extension. RSA/VR, Alicia Ruiz, RSA/VR staff are currently receiving work cell phones to perform their jobs while working from home. 	

- RSA staff are not conducting any inperson meetings.
- RSA are encouraging group virtual orientations for clients from the providers sites.
- The RSA/VR referrals and closures are being monitored for the behavioral health project in VR. There has been a decline in referrals at the beginning of the pandemic as expected. We are starting to see the number increase. We are also monitoring any closures as well as the reason for closure to make sure we are not closing any VR clients that may have been affected by COVID-19.
- Housing, Ryan Vernick updated the council on the COVID Eviction Prevention/Rental Assistance Program. Ryan indicated that the program continues to evolve and that updates and FAQs are posted on the ADOH website
- Ryan provided an update on the Crisis Contingency Safety Net (CCSNF) programs related to the Arizona Shelters. Ryan advised the council that ADOH has partnered with ADOA in providing much needed PPE/Cleaning supplies to the shelters in Arizona and that second round deliveries are underway.
- Ryan also updated the council on the CCSNF contracts that ADOH has with many of the shelters for staffing, operating, and alternative space needs.
- Ryan advised on the status of the 2020 HUD NOFA (Notice of Funding Availability). Ryan advised the council that, due to COVID, there is legislation currently being reviewed by congress which would allow for the 2020 NOFA application to be bypassed and for level funding to be allocated to all CoCs in the 2020 fund year. Ryan advised the council that if there is no action taken on this legislation, then the 2020 NOFA would likely be released later in the year closer to November or December.
