New AHCCCS coverage gives cancer-stricken mom hope

My name is Laura Gargiulo and I am a 45 year-old single mom to Jack, my energetic 11year-old son. I have a bachelor of science in English and a master of education in secondary education and teach part time as an English adjunct professor at Phoenix College. Oh, and one more thing, I don't have health insurance. When facing tough household budget choices that came down to groceries or car payment, I found myself in crises.

After months of struggling with my impossible financial situation, I chose to keep my son's health insurance in place while letting my own lapse. It was a tough choice, but the immediate needs of food and transportation seemed so much more important to me at the time.

And then on Oct. 15, I was diagnosed with stage 3 breast cancer.

"Invasive ductal carcinoma" the doctors called it. It didn't matter what they called it — I had cancer. Cancer. I have cancer? It was just a lump. Women always get lumps. They turn out to be nothing. They must be wrong. They must be. But they weren't. But how? Why me? I don't remember anything the doctor said afterward. He was talking, but the words weren't processing. A cold fear seized me, and I didn't know what was happening. It was as if I received a knock-out blow by Muhammad Ali and those little birds in cartoons were swirling around my head. Cancer. I have cancer.

I have cancer and now I have to deal with it. But I don't have health insurance — that was my first thought. I don't have health insurance.

My second thought was "What about Jack? What about my son? How am I going to get well for Jack if I can't afford the treatments? What are we going to do? What happens to him if I don't survive? What have I done? I was so healthy, I never imagined this. This is what happens to other people, right? I never realized that back when I was juggling my little household budget that the consequences would be so dire. Now what? Am I going to die?

The news was physically and mentally debilitating. I couldn't function. The knock-out blow lasted for days. I didn't know where to start, or what to do. My good friend, Dianne Sikel, who came with me to my appointment that day, had her wits about her. She called me later that day and told me to bring my birth certificate and driver's license. She said she found some program that would insure me because I had breast cancer. She said we needed to drive down there and hand-deliver the application.

I drove to her house and signed the documents she had laid on the table. We drove downtown to the government building and found the office of HealthCheck. It took a while, but we finally found the office. Her name was Virginia Warren and she was the programs office chief. She explained that the Arizona state Legislature had just passed the Breast & Cervical Cancer Treatment Program (BCCTP) under the Arizona Health Care Cost Containment System.

We handed her the documents, and after making sure everything was in order, she looked at me and said, "You're approved. You are now covered by AHCCCS for everything, from your diagnosis, treatment, reconstructive surgery, up to five years after your diagnosis. The state Legislature just passed this bill for breast and cervical cancer patients in August. You are the third person to receive services. If you came in my office three months ago, I would have told you there is nothing we can do for you."

We all cried and hugged each other. It was the first time I smiled since hearing the news I had breast cancer. Within two days I had my health insurance card. Within a week I had appointments with a surgeon and an oncologist. Within two weeks I had surgery for a chemo port and started my chemo treatments.

It is now December and I am still undergoing my chemo treatments. I have four left. I'm not quite sure where I would be today if it weren't for the BCCTP and AHCCCS. I realize how fortunate I am that AHCCCS began this new program. When I first found out that I had cancer, the worst part wasn't that I had cancer, but that I wouldn't be able to take care of my son. I don't worry about that now. I have health insurance. I have coverage. I have hope.

Obviously there are many Arizonan's that suffer because they are not eligible for or cannot afford health care and go untreated. Similarly, these people's conditions become exceedingly more severe because preventative and ongoing treatments were not provided. it would be prudent to treat our fellow Arizonan's before the cost becomes too high in their daily life and our citizens bank accounts.

Moreover, many SMI childless adults have suffered unnecessarily with the cuts. They have been cast aside and provided no medication for their mental illness. As a last resort SMI adults have had to incur costly hospital visits to simply get their mood stabilizer (etc) so that they continue functioning at the shelter they are staying or so that they don't hurt themselves or others. This one woman I had seen had been a paramedic before she experienced personal trauma and became diagnosed with bipolar disorder. She was now living in a park and not a shelter because she could not get her medication. The client reported being "terrified that other people would attack her and was afraid she would have to attack first". This woman had to go to the ER to get her 10 day subscription for a mood stabilizer that would not be refilled after the 10 days and she would remain trapped in the same vicious cycle of not getting treatment.

I am a person who lives with the diagnosis of a serious mental illness. A number of years ago my AHCCCS was cancelled due to making too much on my disability by less than a hundred dollars. After that cuts in the budget forced the public mental health system to make serious decisions on what services they could afford to provide. My medication Abilify, was cut from my provider's formulary. I have been in the SMI system for more than half my life. It has taken much of that time to find a medication that helped me get my psychotic symptoms under control. Abilify has done this.

When I was hurriedly taken off the medication, symptoms of rage, obsessive thinking and homicidal/suicidal ideation took hold. I was awake for days, ruminating on paranoid thoughts of the government. I found myself thinking more and more of expressing this rage by taking lives. Because of my state of mind, I could not separate my normal beliefs about people from the murderous thoughts that consumed me. Out of desperation and because I could no longer live with this torturous me, I took a large overdose. I ended up spending four days in the ICU because my lungs collapsed. I decided that it was to be my life or other's and I chose to end my own.

I am lucky. I lived and did not take anyone's life. I am also so fortunate to have family that has sacrificed to get me my medication. I now get the prescription of generic Abilify from Canada, because it is times cheaper. I am now able to advocate for lives and for society as a whole. I tell my story in hopes of educating people about mental illness and how to help. I wish I could stand up in front of Congress and let them hear my words. They so desperately need to insight into this issue. I hope this part of my story can enlighten someone the people have given decision making power. I am lucky and a rarity to be someone in the public SMI system who has family willing to help emotionally and financially. I am also fortunate that I know how to advocate for myself most of the time. This group of individuals is often marginalized with ongoing stigma that continues to foster misunderstandings surrounding their need for adequate medical and psychiatric coverage. Some individuals require specific medications for psychiatric stability that are far too expensive to pay for out of pocket. One way to establish safer and healthier communities is to allow for individuals to receive necessary funding who are unable to sustain meaningful employment due to their disabilities. In addition, individuals who are receiving SSI / SSDI should not be placed in a "doughnut hole" where they are making a few dollars too much to qualify for medical coverage they desperately need to sustain basic survival.

Who has a 35 year old son with chronic kidney and pancreatic disease. He has been in and out of the hospital in NY for the past 13 months. He can't work because of his disability. He has also applied for Social Security Disability and that is pending. Since he can't work, he wanted to move here to AZ to live with me so he can possibly get well and not incur mounting living expenses in NY, which he can't afford.

He did come here in August 2012 for a visit and was in Banner Baywood Hospital in Mesa more than he was at home during that month. He was here November 2012 to January 2013 and again he was in Banner Baywood Hospital more than he was at home. He is on Medicaid Health Insurance in NY, but because of the freeze of AHCCCS Health Insurance in Arizona for "childless adults" since July 2011, he did not qualify for AHCCCS here, even though he had NY Medicaid. I thought it unfair then to put the freeze on "childless adults" because sometimes even they have nowhere to turn when pressed with debilitating medical issues regardless of having a child or not. In fact, adults with children (and I'm all for the state helping children get medical insurance) cost the state more than if it were to help "childless adults."

I am in full support of Governor Brewer's plan on lifting the freeze of "childless adults" and hope the people of Arizona get it right on helping "childless adults" like my son.

For the last 20 months, the 7/11 revisions in the AHCCS coverage have been harming the Phoenix area hospitals, big time. In September of 2011, after the Law related to AHCCS coverage was changed by the Legislature, charity care + bad debt went from \$8MM/month at St Joseph's Hospital to an average of \$16MM/month. By 7/12, that figure had increased to \$20MM/month, where it has remained ever since. Unless the coverage changes (so that more hospital patients have some insurance), Phoenix area hospitals will spend themselves "dry" - and some will close. The Governor's plan is an excellent one — and it uses an approach that has been utilized in a dozen other States, a self-assessment by the Hospitals to create a pot of money. That "pot" is then sent to Washington and, in 2014, will result in ten times the self-assessment fund coming back to the hospitals. If this plan by the Governor does not succeed, if the Legislature blocks it, the Legislature will be sentencing healthcare in Arizona to a steady decline. That decline will blunt earnest efforts to turn our economic situation around because employers will not locate here nor expand their commitment to this State if medical coverage is so bad that it is pushing hospitals toward an untenable future.

Lisa and her husband are veterans. They have two children. Lisa's economic situation was about to change drastically and she needed help. Lisa is pregnant and concerned about both her and the baby's health. Lisa's previous miscarriages and current gestational diabetes put her in a high risk category. Lisa previously qualified for AHCCCS when she miscarried before the current pregnancy. She was comforted by the fact she could reapply for AHCCCS with one of Keogh's outreach specialists. Thankfully Lisa and her children were approved for AHCCCS, and she can now provide her baby and her children the medical care they need.

Shelly

Shelly is a homeless single mother who struggles to keep her daughter off the streets and in school. Shelly suffers from depression and receives therapy through Magellan. She was introduced to Keogh through Urban Outreach, a homeless program in Tempe. She was relieved that she was able to apply for AHCCCS and food stamps with one of Keogh's outreach specialists, and didn't have to venture down to DES and stand in line. Time that would have interrupted her search for a job. Fortunately, Shelly and her daughter were both approved for AHCCCS and food stamps with Keogh's help.

Angie

Angie asked Keogh to help with an AHCCCS application. She previously tried to apply for AHCCCS, but was unsuccessful. The whole process was frustrating. She and her husband and three children are all U.S citizens. Angie was very concerned because her family couldn't afford private health insurance, and were having a hard time just making ends meet. She worried about her oldest daughter who was having liver problems, and doctors were suspecting that she may have liver cancer. Needless to say Angie was relieved to receive a letter saying

that her whole family had been approved for AHCCCS. She now has peace of mind knowing that her daughter and the rest of her family have healthcare coverage.

Nancy

Nancy works in a adult ESL class at a Mesa elementary school. Nancy's husband recently lost his job, and she knew that with her small income she was not going to be able to afford private health insurance. Nancy heard about Keogh's services through a presentation her ESL class. When Nancy's financial situation changed dramatically she called Keogh to help her apply for KidsCare. Sadly after Nancy had completed her application she was told that her children would be put on a waiting list because an enrollment freeze had been placed on KidsCare just as her application was received for processing. She was frustrated because had she applied only several weeks earlier, her children could have had healthcare coverage. Nancy knew she was over income for AHCCCS and didn't know what she was going to do. Fortunately, Nancy was referred to several sliding fee scale clinics that would be accessible in case her children were ever in need of a doctor.

I have firsthand knowledge that it takes approximately 2-3 months to have my children's services start. Then the services are limited. They aren't approving special therapies due to budget cuts. I work with a very difficult population of youth. These are the kids that if they don't receive serious intervention they are at risk of the violence we have seen across our nation.

I attempted to get services for one of my kids who aged out of CPS and was declared an SMI adult. Because of the length of time to get her seen by a psychiatrist and start therapy she placed herself in a living situation that was very unhealthy. She is now a pregnant, drug addicted 18 year old. She was taken advantage of a man who was harboring AHCCCS young adults for his own profit. I spoke to CPS and APS and they were unable to take any legal action to prevent this young lady from being victimized. We tried to protect her. I haven't heard from her so I pray she is still alive.

I urge our state to take mental health seriously. Please don't use these programs to balance our budget problems. It will end up costing our state and the lives of the people in our community. I don't believe it starts with gun control. I believe it starts with the reasons these youth are unstable and addressing those needs. Many of our families don't qualify for AHCCCS anymore due to stricter guidelines. There needs to be special consideration for mentally at risk youth just like there is for adults.

Health care is a business and economic driver in Arizona, similar to the aerospace or defense industries. The healthcare sector makes effective use of private and public funds to create jobs, support ancillary services and support the purchase of local materials. Statewide, the hospital industry is 63% larger than the hospitality industry and 37% larger than the electronics and aerospace industries combined.

Throughout the "Great Recession," hospitals were one of the few industries that did not experience massive layoffs and largely retained or enhanced employment levels. But the continued economic downturn and the
dramatic rise in the uninsured, which occurred last fiscal year (more than 140,000 people lost their insurance
due to state budget cuts), has put an unsustainable strain on hospital finances from patients who need services,
but are unable to pay.

Governor Brewer's plan to restore Medicaid coverage is a sound one. Arizona voters have twice approved providing Medicaid coverage to Arizonans below federally-designated levels of poverty, and the Governor's proposal would help fulfill the will of the voters.

There also is a clear economic argument to be made for this plan. Arizona needs to stay competitive in the region – since so many of the other western states are maximizing the Medicaid dollars, we will be at a strategic disadvantage if we do not do the same. The Governor's plan will inject \$2 billion into our economy, keeping Arizonans' tax dollars in Arizona and helping to maintain and create thousands of jobs in the state. The plan will also alleviate the burden of uncompensated care costs that get placed on businesses and Arizona families who are paying higher rates to compensate for uninsured patients in need of care.

We encourage business and community leaders throughout the state to support the Governor's proposal as a cost effective way to provide insurance for more than 240,000 Arizonans and to help our economy continue to move into full recovery.

Many think that all children with disabilities are covered under some type of public program. While our son once qualified for ALTCS, Matt is no longer medically eligible. This is a positive thing, since it means Matt is no longer at risk of needing institutional care. He received services and supports from state programs that improved his health status and his functional abilities. We celebrate this as a great return on the investment the state made in Matt's care.

Like many young adults, Matt is on a path to independence. Matt was included in public school under the IDEA, and graduated with his diploma and a 3.7 GPA. Matt anticipated and planned for community college, integrated community living, and employment opportunities.

However, Matt's disability meant he could not enroll as a full-time college student, and his disability meant working part-time. Matt is now 26, lives at home, unmarried and a childless adult. Many young adults with disabilities need medical insurance to remain healthy and employable.

Families like mine strongly support the Governor's decision to expand Medicaid eligibility. Access to healthcare supports a path toward independence for youth with disabilities who are not covered under public programs.

The Governor is keeping faith with the will of Arizonans who already approved this expansion with their votes.

I urge our state legislators to do the same.

My youngest son was diagnosed with Mature B Cell Leukemia at the age of 5. He is now 14, Cancer Free. I am concerned about him being labeled as high risk by insurance companies. I have worked all my life and have thus, only been eligible for a state health plan during the 2-3 years was in treatment. Since then, we have always been deemed ineligible due to my income. I currently make <\$35,000 a year, my husband has no income to speak of, and we have 3 children 18 or under.

When is out on his own, he will be a working, contributing member of society and thus ineligible for a state health plan. He will also not be able to afford the expensive high-risk insurance premiums. What is he to do?

Last July, was flown out from our community of Page, to Phoenix Children's Hospital for emergency surgery to remove two large non-cancerous tumors from his spinal cord. With insurance, the flight co-pay was over \$8,000 + another \$8,000 from both hospitals. We live paycheck to paycheck. If I can't afford these expenses, how will he, when he is no longer covered under my insurance? Is this label going to affect his attractiveness to be hired? Will credit agencies see him as a possible loan risk?

If I can not pay these medical bills, what am I going to do if this happens again? Adding to our plight, I was diagnosed with Kidney Cancer and under went surgery a year ago January, those bill were over \$10,000 after insurance.

Due to our history, are my other children going to be lumped in as high risk? What about stop? If you let it start now, how big will the elephant be 10, 20 years from now?

Dear Sirs,

I have had 43 years of experience providing healthcare to all socio-economic segments of the community here in Tucson. It includes 5 years of service at Pima County Hospital, 21 years with Group Health Medical Associates, and the balance in small group practice. Since my retirement 2 years ago, I have served as Medical Director at Clinica Amistad, a free clinic in South Tucson that serves patients with medical problems and who have no form of health insurance. All who serve there, including doctors, nurse practitioners, physician assistants, registered nurses, and multiple volunteers who are working towards healthcare careers, do so without pay. The patients are not charged for services, including lab, X-Rays, Ultrasound studies and specialty consultations provided by community physicians. Our costs are supported by community donations and grants.

Since there was a restriction in AHCCCS coverage there has been a marked increase in the numbers of patients seen. The majority of them have serious medical problems, mainly diabetes, hypertension, high cholesterol levels and a variety of other ailments. Our data shows that we saw as many new patients through June of 2012 as were seen in the entire year of 2011. Half of our patients are employed but lack health insurance, either because it is not provided or is too costly for them to afford. Overall, 78% of our patients report living below the poverty level. We believe that we have prevented many patients from seeking care at emergency rooms and possible hospitalization.

There is no doubt, judging from the above experience, that the expansion of Medicaid/AHCCCS would be a necessity to preclude an even larger number of Arizona citizens being left without basic healthcare protection. Operations such as ours cannot possibly fill the vacuum. Therefore, expansion of the healthcare safety net would be the humane and right thing to do. Please do so.

I am both a high earning tax payer and run a multimillion dollar business throughout Maricopa County. I come from a divorced household growing up. My mother kicked me out of my home when I was barely 16 and she moved out of state. I completed the rest of high school on my own and then applied for college. If it were not for governmental assistance and student loans, I would not have made it. I was on Food Stamps, AHCCCS, and Federal Student Loans and Pell Grants for a few years, totaling 2.6 years.

That was an incredibly smart business decision for the state of Arizona, because I pay more taxes in one year with my income than the state paid out during my struggling years. I do not begrudge taxes and I do not want them reduced if it means that social programs will be reduced. I also run a business and we offer health coverage to my staff, we will continue to pay for the healthcare even if full healthcare reform occurs within Arizona. Arizona should have healthcare insurance that covers every person who earns below 133% FPL for free and ideally should cover the fees up to about 170% FPL. I know how hard it is to make a living and a person should not have to choose between food on the table, a roof over their heads or health coverage. Not everyone has family they can depend on or people to barrow money or lend support. My name is . My sons are and . Both boys have severe hemophilia A. It means they have less than 1% blood clotting levels and they spontaneously bleed into their joints, muscles and soft tissues. It's a very painful, lifelong disease. There is no cure and medications are currently \$2,300 a box and it takes two boxes per shot. Shots are given three times a week for life. Each child. Both boys suffer from target bleeds that have already damaged their knees, ankles and elbows. Clotting injections are the ONLY thing clotting my children's blood. Without them, they suffer and eventually die, depending on the site.

My husband, ..., suffered a massive stroke at the age of 22 due to an enlarged heart caused by a random unknown virus. It paralyzed his whole right side and took his speech. Eventually he was give a heart transplant by the state of Utah. Sadly he passed away seven years ago, leaving me alone in this battle.

As it stands now, my sons are 16 and 18. My 18 year old, cannot move from my home and branch out into independence because the second he leaves my home he can no longer clot his blood without Medicaid. He's a full time high school student so is not working yet at this time, although he's been applying for over a year and a half.

When I contacted D.E.S to discuss options for my young adult, I was told there is zero help for "childless adults". While I understand the logic here, I also know that not everyone can fit into a cookie cutter system. I urge you to recognize that certain life threatening conditions require that people need an extra bit of help till they can mature a little more and establish themselves. An environment that has adequate affordable health care.

When I asked D.E.S about what my child can possibly do to still get clotting injections and try to be independent, I was told, and I quote verbatim, "Unless your sons get someone pregnant, they won't be able to obtain any clotting medicine once they leave your home." Astonished I asked for her full name and said I wanted to quote her, she declined, for obvious reasons

My treatment has been literally life-changing, and possibly life-saving. I've been in pain for six years now, but my life is full and happy, and I never would have been able to achieve that without the tremendous support from my medical team--which, in turn, I'd never have been able to afford out of pocket. Please consider the large number of childless adults, including the homeless and near-homeless, dealing with complex medical and behavioral health issues. Consider the costs of covering emergency room visits to substitute for primary care. Regardless of federal matching funds, keeping AHCCCS for childless adults makes sense financially and ethically.

This is the second time I have written something regarding being a childless adult in Arizona. First, I want all of you to know that I do not like being dependent on the State for insurance but my situation continues to hamper me so I turned to the State for help. I am a 54 year old childless adult and when I HAD coverage I never used it. Now that I have no coverage I have had to struggle through difficult health issues with NO help at all.

First---I have asthma. When I had health coverage I was living where my asthma rarely bothered me. But I wound up living in the west valley. Have you looked outside this spring? The desert has sprung to life after a soaking rain a couple of months or so ago. Things have grown where there was nothing. Everything seems to be blooming and pollinating. Ask any allergy sufferer about it. Those of us with asthma are paying the price as well. I have no insurance to get the inhalers or oral meds I need to be able to breathe easily. I've had to curtail my activities to watching a lot of TV because I must remain quiet in order to breathe.

Second---I have ongoing problems with my feet now and they need to be treated. But again I cannot do one thing about it. I'm fairly certain that if I got treatment for my feet, it wouldn't involve that much but if they continue to go untreated.....who knows? I could wind up in the hospital having very expensive treatments instead of a couple trips to the doctor and a prescription.

Third---For the first time in my life, I got a boil. Not some little pimple thing.........No, I got one the size of a golf ball. I'm now three weeks into trying to heal it with home remedies. Many people do this all the time so you may be thinking its no big deal. I was exposed to MRSA in late 2010 to the point that two medical professionals told me that I more than likely have MRSA colonized on my skin and probably always will. I have to treat any open wound, even tiny ones as if they are major lacerations. When seeking treatment, I have to tell any health care person that I was exposed to MRSA.......for the rest of my life.

The boil situation was complicated because I was allergic to every adhesive tape we tried and now I have a ton of rashes all over my arm from the tape. So here I am not having any idea of I got MRSA fired up in any of my 'wounds.' Another person who was involved with caring for the same MRSA patient that I was involved with; was bitten by a brown recluse and MRSA was found in the bite wound. So the threat is real. And I spent far more time with the original MRSA patient helping with their personal care and changing wound dressings at home for them than the spider bite victim did. Again the threat is real.

I need to have my medical situations attended to so I can look for work and be able to be there everyday when I finally find a job. I need help and just because I chose to remain single and not have children I should NOT be penalized for that decision. I have been in DES offices in the waiting area and heard women say they deliberately had a baby so they could get help. So now you have TWO persons getting help instead of one. All I need is some help here. I would be most happy to be completely dependent on myself if I could. But right now I need the health insurance that was available to me in the past to be reinstated so my problems will not escalate into major problems that will land me in the hospital or if no hospital will take me.....die.

Hello,

I work with cancer patients and would like to share a story of one of our adult patients who lost his AHCCCS medical benefits in June 2012 when his youngest daughter turned 18. This man had been on disability for about a year prior due to a diagnosis of Stage IV malignant melanoma. He was being successfully treated, meaning he was receiving chemotherapy and the disease was not progressing. Once he was released from AHCCCS in June 2012 he was fortunate to receive charity care from our hospital which covered 80% of his medical bills. However as of Oct 2012 he had an outstanding balance of \$10,000 - his 20% share. That same month, while sitting in an exam room with his Dr. and with the presence of his 18 y/o daughter and his mother, made the difficult decision to stop treatment because he could not conceive of increasing that \$10K debt. His disability Medicare benefits would start in April 2013 and he said he would start treatment again at that time. Myself and his social worker were present and if I could have transported Jan Brewer to that room in that moment, I would have. This heart breaking scenario unfolded. The cruelty and injustice was hardly comprehensible. This man and his family were surrounded by world class cancer researchers and cutting edge treatment – just down the hall and up the stairs. There is no doubt his disease would progress by the time April 1st 2013 rolled around very likely shortening his life, quite possibly by years.

This patient had 2 emergency hospital admissions in Feb and again in late March just days before his Medicare would kick in. He and his family are sinking in medical expense debt but incredibly their resilience is intact and the 18 y/o daughter is the very face of courage as she watches her father deteriorate at the hands of a system well equipped to treat him but completely inaccessible.

He will learn to what extent his disease has progressed next week. He tells me that this is all he wants to know and that he knows he will die from this disease and with the likelihood of significant advance, he wants to forego additional palliative treatment so that he may enjoy the time he has left with his family.

It is very possible that he could live a quality life for many, many years despite his incurable disease. Our system failed this man and his family and next week will reveal just how much.

Will I be forced to watch my congestive heart failure patients and diabetes slowly be taken over by their disease states and die? Will emergency rooms in Tucson we even more congested and eventually close due to lack of funding? I have already watch these things happen to other human beings when the state of Arizona pulled funding for illegal immigrants. Must I watch this happen to U.S. citizens?

Personal story:

My son was recently involved in an accident; this was not planned. He was hospitalized for almost a full week, luckily he has recovered from the accident. Doctors say he was very lucky to sustain the types of injuries he had. Follow up was critical and we had attended many follow up appts from July through February 2013 and traveled 240 miles round trip. I am a single parent with five children, my pay is not great, feeding clothing my family etc. is difficult at times. The travel put a strain on my budget. Luckily my son had AHCCCS to help pay for the costs. He was asked to pay \$25.00 at one time which I immediately paid but later the check was returned to me as paid in full he does not have a job). Without AHCCCS I would not be able to afford the payment or billing for his immediate and short term care. Insurance costs are high and as it stands currently, I live in an area where the nearest private clinic or health care facility is 70 miles away. (wear and tear on my vehicle, gas, meals and time to travel). WE have an Indian Health facility but have limited services here.

Again, this accident was not a planned event and we are thankful that AHCCCS was available to help pay for my sons accident. He is an adult and has no children. Jobs are scarce on the Hopi reservation.



The Impact of no medical coverage

On March 26, 2013 I was stopped at a red light at a pedestrian crossing. I was rear ended by a larger vehicle (which caused nearly \$8,000 damage to the vehicle I was in). I was taken on a backboard with a cervical collar to the emergency room. Tests were run on my skull and brain. Thankfully I had insurance. I worked full time at a local manufacturing company as a buyer. I followed up with my primary care physician the following day and at that time couldn't feel much of my left hand, had a headache equivalent to a migraine that wouldn't go away and could not move my left arm very well nor did I have a normal gait. He referred me to a clinic that worked on rehabing my spine.

I was unable to sit, stand or even lay down for more than 30 minutes at a time without adjusting, changing my position and being miserable and in horrible pain unless I took the pain medication and muscles relaxers prescribed. Two weeks into treatment and I was just beginning to feel my left hand again and could move my head more than a tiny bit. I was placed on FMLA by my employer after exhausting my PTO and "floating holidays".

On April 26, 2013 I was laid off. With that comes the lack of medical insurance unless of course, you can pay the \$700 a month for COBRA. Well, considering unemployment is only \$240 a week, (and that is being decreased by 16% next month) how is one supposed to afford COBRA premiums plus co-pays of \$30 per doctor visit and a minimum of \$20 per prescription? That leaves me a choice of rent and utilities like electricity to apply for jobs and water so I can be clean for interviews or Health Care.

I have a medical illness that requires daily medicine. With insurance it costs \$50 a month, without it costs nearly \$400. That doesn't include the medicine required to control asthma or high blood pressure.

I am dumbfounded that a person who is working, paying for their own medical and through no fault of their own finds themselves without a job can't get medical coverage. It leads to a perpetual vicious cycle. Without medication I can't work, without work I can't get medication. I thought that was what the AHCCCS was set up to assist with...I thought the original intent of "Welfare" was for the working "man" who suddenly found their-self in dire straits. I am not sure how this equates to fairness or just when a person who has worked for years and paid for those on welfare and the healthcare of others through taxes, suddenly can't rely on that same system.

Pituitary Brain Tumor:

I have an excruciatingly painful 2.5 cm pituitary brain tumor. I don't have health insurance because I just graduated from college in December and can't get a job until this tumor is surgically removed. Even though I am below poverty level, AHCCS Health denied me because I am single, without children. I have absolutely no way to pay for the highly specialized medical treatment I need without insurance or financial assistance. My only hope of getting the healthcare I need is to qualify as a charity case now that AHCCCS Health is no longer accepting applicants that are single, without children.

I am 38 now and was diagnosed with cervical cancer at 36. I worked in the food industry for over 14 years and they didn't provide health insurance. Because I had no insurance I didn't go for my yearly exams. I had some irregular health issues so I went to the county hospital and they ran some test. That is when I found out I have cervical cancer. I never had any other symptoms so it never dawned on me to get checked. Once I found out about the cancer, I had applied for AHCCCS but was denied because I have no children. I had no other options for care and my doctor told me about charity care at St.

Joseph'. I have been receiving care through them since 2010. I needed a surgery but the charity care had run out of funds and I still didn't qualify for AHCCCS. My husband happened to get a job that offered health benefits, so I was able to get the surgery. He was later laid off, so I lost health coverage again. At this point I didn't qualify for pre-existing insurance because you have to be without insurance for 6 months...I applied for AHCCCS but again was denied.

Please help! Just because we don't have children doesn't mean we don't need help. I have worked my entire life and now am in a situation to where I cannot get any help when I need it the most.

My name is and I am an electrician by trade. Due to the long economic down turn I have become homeless and unemployed. About two months ago lifted a box to help a friend and got a hernia. I can not look for work and can not do anything, It is painful and has dropped into my scrotum.

I went to John C Lincoln a non profit hospital and told them I had no insurance, after many weeks of no return of phone calls to agencies for help. I told them I didn't have insurance and that I didn't want to create a bill I could not pay. I told the same thing to every person I saw including the Dr. They assured me it was OK. The Dr. then told me if I could get the hernia to reduce by pushing it up it was not considered an emergency and I could not be helped without insurance. Then comes the billing girl which told me my 10 minute consultation and blood pressure check would cost me \$5000.00.

I asked to talk to a social worker that explained to me that because I had no children I could not be helped.

So here I am, the building starting to improve and I can't get off the couch. My income for the last 6 months was less than \$2000.00. I don't know how I would eat if it was not for friends.

I have paid taxes all my working life and at 55 years old feel discriminated against and betrayed when the only time I have ever asked for help from the government I can't get any.

I was 26 when my accident occurred (June, 2012), working part-time and going to school full-time. I was unable to afford insurance (starving student) and didn't qualify for AHCCCS because I am a single adult with no children. I was in an accident that broke my neck and caused severe nerve damage that has affected the use of my left arm. I was in ICU and had to have an emergency ACDF. My medical bills are through the roof! Even with the discounts, my medical expenses are beyond what I will ever be able to pay back.

The worst part at this point isn't the bills, it's the fact that I need more tests and possibly another surgery to see what it is I am dealing with, which I haven't been able to get because of the cost. The medication that gives the most relief for my chronic pain is over \$200 a month, which, again, I don't buy because I can't afford it. My family has helped out so I can continue with physical therapy, but it is costly. I am unable to work, and can't do much with school because of my physical issues. I was working at getting my bachelors in nursing, but I cannot do the job if I don't get better and I can't get better if I don't have some help. Yes, I applied for disability, but like everything else, it is a waiting game. As I wait to see which might come through first, I am worse off. Every day is a step backward at regaining what was lost with my nerves alone. I could be a productive member of society, but I can't if I continue to get worse.

There are so many other people out there that have it worse than me. I can only imagine what that must feel like. We need help.

This is what has happened to my life since the waiver and loss of my AHCCCS coverage, and continued denial to this program as well as being denied SSDI and all other related programs.

In 2006 I was unemployed and had been since 2003 because I had developed osteoarthritis and it had affected my right hip so severely that i almost could not walk anymore. I applied for AHCCCS when it became apparent that I could not return to work or be hired in my condition.

On AHCCCS I was able to go for an exam with a PCP who referred me to an osteopathic surgeon.

of AZ Orthopedic Pain and Fracture Surgeons. He looked at the x rays and told me if I did not get a full right hip replacement my femur would snap off inside me. There was no cartilage left and the top of the bone was covered in cysts—that had ruptured and the bone was becoming brittle. He requested approval for immediate surgery through my provider which was "Mercy Care". They approved it and within a week I had the procedure. I recovered fairly well and was finally able to walk more normally although the 3 years it took while I was uninsured and walked progressively worse had taken their toll and left me with some bad back problems. I had a pinched nerve in my lower back and one foot was noticeably deformed by the pressure of coming down on it with more of my weight than the other since i preferred my left due to the increasing pain before the operation as the hip degenerated.

I went back to work as soon as I was done with the physical rehab. Because my income increased i was no longer illegible for continued AHCCCS.

The company I worked for was small family owned and did not offer any health care. My salary did not leave room in our budget for independent insurance.

I was laid off in 2010 when the economy collapsed with the housing market. The company I had been working for was a courier company that dealt mostly in real estate documents. A bad housing market meant cutbacks to their staff. while we were struggling to right ourselves my husband became very ill. he was on AHCCCS and was told he needed to retire early due to degenerative disc disease, severe osteo-arthritis in all sectors of his back. Bone spurring and spondylitis causing him severe pain and headaches compounded by 3 kidney stones one unusually large stone had embedded itself in the

It is ridiculous and a waste of funds allowing me to be permanently crippled by not funding the procedure I need to maintain my independence.

I look back on my choice to move here to Arizona back in 1991 with great regret. I am severely depressed and even though I am only 52 I feel like my life is over. I wish the states and the federal government would stop bickering over budgets and monies promised before it leaves a permanent mark on my life. I worked much of my adult life like anyone else yet I am to have no pleasant retirement or golden years ahead. Caught in a catch 22 of sorts I feel that I am part group of people that those in an economic class above me have decided are dead weight on society and the message is go away stop making so much noise and die quietly you are not worthy of any more of a life than this. shame on Arizona

I am but a small example of the people out there suffering because money has become more important than people.
