**Please Note:** Arizona Law 2015, Chapter 19 Section 9 (SB 1480) enacts that from and after June 30, 2016 the provisions of behavioral health services under Arizona Department of Health Services/Division of Behavioral Health Services (ADHS/DBHS) is transferred to and shall be administered by AHCCCS.

## POLICY 448, HOUSING

The Division of Behavioral Health Services Policy 112 has been converted to ACOM Policy 448, Housing and will now be administered through AHCCCS. Definitions, clairification and content were updated and revised to include current Hosing requirements for Contractors. Contractor requirements that were part of the Housing Desktop Manual were also incorporated into this Policy. In addition, references surrounding original reporting to DBHS have been revised to report to AHCCCS.
