POLICY 306, ALTERNATIVE PAYMENT MODEL INITIATIVE – WITHHOLD AND QUALITY MEASURE PERFORMANCE INCENTIVE

ACOM Policy 306 is a new policy that combines the the quality distribution aspects of ACOM Policy 315 and ACOM Policy 318. The terminology Value Based Purchasing (VBP) was updated to align with Alternative Payment Model (APM). With respect to the name change to APM, the quality distribution was further separated into withhold and incentive sections. *Effective Date will be made retroactive to 10/01/17.*

POLICY 307, ALTERNATIVE PAYMENT MODEL INITIATIVE – STRATEGIES AND PERFORMANCE-BASED PAYMENTS INCENTIVE

ACOM Policy 307 is a new policy that combines the performance based payment component and contracted spend concepts from the previous ACOM Policies 315, 318, 319, and 322. New ACOM Policy 307 includes a sanction criteria table. Effective Date will be made retroactive to 10/01/17.
