INFORMATION REGARDING COVID-19

ACOM POLICY 307 - ALTERNATIVE PAYMENT MODEL INITIATIVE - STRATEGIES AND PERFORMANCE-BASED PAYMENTS INCENTIVE

ACOM Policy 307 was revised to apply name change for CMDP from Comprehensive Medical and Dental Program to Comprehensive Health Plan (CHP) effective April 1, 2021, due to CHP behavioral health integration. Definitions were revised and percentages of spend requirement tables were updated to include CYE 22 requirements. Additional updates include removing Medicaid Accountable Care Organization (ACO) reporting requirement and minor formatting and clarification were done throughout the Policy.

Policy has a retroactive date of 10/01/21.
