Dear Speaker Mesnard:

A.R.S. § 36-2903.08 includes the following requirement:

On or before August 1, 2014, and annually thereafter, the Arizona Health Care Cost Containment System (AHCCCS) Administration shall report to the Speaker of the House of Representatives, the President of the Senate and the directors of the Joint Legislative Budget Committee and the Governor's Office of Strategic Planning and Budgeting the following:

- 1. The amount each hospital contributed for the hospital assessment authorized pursuant to section 36-2901.08 in the previous fiscal year.
- 2. The amount of estimated payments each hospital received from the coverage funded by the assessment.

AHCCCS submitted the August 2016 Report with the information requested in the first requirement, but based on the timing of the deliverable the data contained in the second requirement was not available. As explained in our August Report, health care providers typically take some time to submit health care claims to payers (e.g., AHCCCS contracted health plans). Payers must then review and pay the claims. Upon payment, paid claims are sent to AHCCCS by the health plans. Thus, it can take 3-6 months before the paid claims data appears in AHCCCS' database, with the average lag closer to 6 months. AHCCCS stated in the Report that we intended to provide the data by January 31, 2017.

Please find enclosed the amount each hospital contributed for the hospital assessment in State Fiscal Year (SFY) 2016 as well as the estimated amount each hospital received from the coverage funded by the assessment.
